917. PARENT & FAMILY ENGAGEMENT

Purpose

The Board recognizes the vital role parents/guardians and family play in the education, welfare and values of their children. CCA is committed to the belief that all students can learn and acknowledges that schools and families share a commitment to the educational success of students.

PART I. GENERAL EXPECTATIONS

The Commonwealth Charter Academy agrees to implement the following statutory requirements:

Section 1116 (a)(2),
ESEA, 20 U.S.C
§6318

- CCA will put into operation programs, activities and procedures for the involvement of parents and family members in the school with Title I, Part A programs, consistent with section 1116 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents and family members of participating children.
- Consistent with section 1116, CCA will work to ensure that the required school-level parent and family engagement policy meet the requirements of section 1116(b) of the ESEA, and each include, as a component, a school-parent compact consistent with section 1116(d) of the ESEA.
- The school will incorporate this parent and family engagement policy into its LEA plan developed under section 1112 of the ESEA.
